INFORMATION EX ART. 13 EU REGULATION 2016/679

Data Controller

We inform you that, under EU Regulation 2016/679 (infra: "Regulation"), your Personal Data, collected for the purposes of management of the contract and for the compliance of legal obligations will be processed by LUILOR S.P.A. based in Montemurlo, Via dei Tintori 13/15/17 - VAT IT01584320970 as data controller ("Data Controller").

Types of data object of the treatment

The Data Controller will process the personal data as defined by the Regulation, collected during the management of the pre-contractual and contractual relationship, including, by way of example and not exhaustive, your name, surname, address, landline and mobile telephone number.

Purpose, legal basis and optional treatment

Your Personal Data will be processed, without the need of your specific agreement to handle the pre-contractual and contractual obligations and fulfill the legal obligations.

The data will be processed for the following purposes:

- Evaluation of new suppliers. At this respect, among the personal information object of the processing, there may also be judicial data (as per Article 4 c.1 letter e) of the Code;
- Management and execution of pre-contractual obligations;
- Management and execution of the obligations arising from the contract or from the management of the order;
- Provision of the main services and / or accessories related to the contract or order;
- To fulfill the obligations established by D. Lgs. 81/08 in relation to health and safety at work (for example, request of the names of your staff - surname and first name, matriculation number, place and date of birth, date of employment) who will carry out interventions by our offices with specific declaration on the possession of the requirements of professional technical suitability and relative indication of the INPS and INAIL position and CCNL applied);
- Execution and compliance of the obligations required by laws, regulations and community legislation;
- Controversy's management.

The legal basis of the data processing are the performance of a contract or pre-contractual measures, and the compliance with a legal obligation.

Recipients of your Personal Data

Your Personal Data can be shared with:

- natural persons authorized by the Data Controller to process Personal Data after signing a confidentiality agreement (es. HR / administrative employees, system administrators);
- consultants, credit institutions for administrative and accounting purposes, contractors in case any work is assigned to third Companies - some of them is to be considered as Data Processors, contracting companies for individuals security purposes;
- subjects, entities or authorities we are compelled to provide your Personal Data to by virtue of provisions laid down by law or by order of the authorities.

As regards the possibility to transfer Data to Third Countries, the Data Controller advises that they will be processed according to one of the procedures permitted by the current law, such as the consent of the person concerned, the adoption of Standard Clauses approved by the European Commission, the selection of subjects adhering to international programs for the free movement of data (es. EU-USA Privacy Shield) or operating in Countries considered as safe by the European Commission. For further information, kindly apply to the Data Processor.

Personal Data Retention

Your Personal Data will be kept for the time of management contract. In some specific case they can be kept over that date according to the applicable local regulations.

Your rights

You can request to the Data Controller the access, the cancellation or the revision of them, or to stop the treatment of personal data at any time. You can also request to reduce the treatment of your Personal Data to those cases mentioned on art.18 of local regulations, and they have to be provided in a format / file of common use and readable from automatic system, according to art. 20 of regulations.
